3 (a) The objects to be pursued by the company on its incorporation are:

1. To promote charitable objects by providing food, nutrition, shelter, and other essential support to persons and communities affected by poverty, homelessness, distress, calamities, or any form of vulnerability.
2. To establish, maintain, operate, and support shelters, community kitchens, food distribution centres, and relief facilities for the underprivileged, including children, women, senior citizens, and other needy individuals.
3. To undertake initiatives for hunger eradication, malnutrition prevention, and community welfare, including food banks, ration assistance, and emergency relief programs in furtherance of the Company's charitable purpose.

(b) *Matters which are necessary for furtherance of the objects specified in clause 3(a) are

1. To acquire, hold, lease, or use movable and immovable property such as land, buildings, equipment and facilities necessary for carrying out the main charitable objects of the Company.
2. To receive donations, grants,

contributions, subscriptions or assistance in any lawful form from individuals, trusts, companies, government bodies, or international organisations solely for promoting the objects of the Company, without distribution of profits.

3. To collaborate, affiliate, or enter into arrangements with Government departments, NGOs, charitable institutions, corporate entities (including CSR initiatives), and other bodies for better implementation of the Company's objects.

4. To appoint staff, volunteers, experts, consultants, and service providers as may be required for effective execution of food, shelter, and welfare programs.

5. To undertake training, research, surveys, studies, seminars, awareness programmes and capacity-building activities related to hunger relief, shelter, community welfare, disaster support and related social causes.

6. To prepare, publish and circulate reports, journals, audiovisual materials, digital content, and other publications supportive of the Company's charitable objectives.

7. To open and operate bank accounts, manage funds, and make permissible investments strictly in accordance with the Companies Act, 2013 and applicable laws, ensuring that all income is applied solely towards the objects of the Company.

08. To do all such lawful acts and things as are incidental or conducive to the attainment of the main objects, provided that the Company shall not distribute any profit or dividend but shall apply its income solely for its charitable purposes.

the doing of all such other lawful things as considered necessary for the furtherance of the above objects:

Provided that the company shall not support with its funds, or endeavor to impose on, or procure to be observed by its members or others, any regulation or restriction which, as an object of the company, would make it a trade union.

The objects of the company extend to the whole of India.

5 (i) The profits, if any, or other income and property of the company, when-so-ever derived, shall be applied, solely for the promotion of its objects as set forth in this memorandum.

(ii) No portion of the profits, other income or property aforesaid shall be paid or transferred, directly or indirectly, by way of dividend, bonus or otherwise by way of profit, to persons who, at any time are, or have been, members of the company or to any one or more of them or to any persons claiming through any one or more of them.

(iii) No remuneration or other benefit in money or money's worth shall be given by the company to any of its members, whether officers or members of the company or not, except payment of out-of-pocket expenses, reasonable and proper interest on money lent, or reasonable and proper rent on premises let to the company.

(iv) Nothing in this clause shall prevent the payment by the company in good faith of prudent remuneration to any of its officers or servants (not being members) or to any other person (not being member), in return for any services actually rendered to the company.

(v) Nothing in these clauses (iii) and (iv) shall prevent the payment by the company in good faith of prudent remuneration to any of its members in return for any services (not being services of a kind which are required to be rendered by a member), actually rendered to the company

6 No alteration shall be made to this memorandum of association or to the articles of association of the company which are for the time being in force, unless the alteration has been previously submitted to and approved by the Registrar.

7 The liability of the members is limited.

9 True accounts shall be kept of all sums of money received and expended by the company and the matters in respect of which such receipts and expenditure take place, and of the property, credits and liabilities of the company; and, subject to any reasonable restrictions as to the time and manner of inspecting the same that may be imposed in accordance with the regulations of the company for the time being in force, the accounts shall be open to the inspection of the members. Once at least in every year, the accounts of the company shall be examined, and the correctness of the balance-sheet and the income and expenditure account ascertained by one or more properly qualified auditor or auditors

10 If upon a winding up or dissolution of the company, there remains, after the satisfaction of all the debts and liabilities, any property whatsoever, the same shall not be distributed amongst the members of the company but shall be given or transferred to such other company having objects similar to the objects of this company, subject to such conditions as the Tribunal may impose, or may be sold and proceeds thereof credited to the Rehabilitation and Insolvency Fund formed under Section 269 of the Act.

11 The Company can be amalgamated only with another company registered under section 8 of the Act and having similar objects.
